#### **FIRE & SAFETY**

Gas caps must be locked or taped shut and fuel should be less than 1/4 tank full. Batteries must be disconnected. All keys must be kept on event site.

#### **PARKING**

Parking is available at the OC Fair & Event Center. **Hang Tags, must be purchased in advance for \$15 (\$5 per event day).** See order form for further information.

We will make every effort to place vendor parking close to the exhibit areas. Accommodations will be made to allow exhibitors to load / unload product prior to event opening daily.

#### **TENT / CANOPY GUIDELINES**

**Tents are not allowed inside the buildings**. Standard 10'x10' inline booths utilizing a canopy or tent must be a minimum of 8' high with a maximum height at peak of 12'. The entry point of your tent should be a minimum of 7'.

Any tent larger than a 20'x20' will need Fire Marshal approval and will require a fire extinguisher.

All tents and canopies must be tethered to the ground. Staking will not be permitted. Use of weighted barrels or cinder blocks is recommended to properly tether the canopy or tent to the ground.

Anything used to secure your tent can be no more than 2' outside the footprint of your tent.

### **CAMPING / RV INFORMATION**

#### WIFI

WIFI is available at the OC Fair & Event Center, but is limited in certain areas throughout the venue

#### PFTS

Only service animals are allowed on the grounds based on state and national ADA laws. They must always remain on a leash and owners are required to clean up after their pet.

Anyone bringing an animal will be responsible and liable for any damage or injury caused by the animal.

## THIRD PARTY SERVICES

#### **DISPLAY LABOR**

There is no on-site labor available. If you require additional labor to assist with your booth set-up and tear down, you will need to order labor in advance from a Third Party Vendor.

#### **ELECTRICAL INFORMATION**

Power is available at the venue but is limited. We cannot guarantee your exhibit will be located close to a permanent power source. If you require power, an Electrical Order Form will need to be submitted. Power will be turned on at least 30 minutes prior to event opening and will remain on for a limited time after closing.

We recommend considering a generator for your power needs. All generators must be turned off at close of each day.

#### FREIGHT / MATERIAL HANDLING (DRAYAGE)

We encourage all exhibitors to ship items to the Advance Warehouse. Using this method is most cost effective and will save money.

There will be a charge to handle and deliver shipments from the Advance Warehouse and on Event Site.

By using the Advance Warehouse services, you are eligible for outbound shipping. A Material Handling Form must be completed for all freight shipped to the Advance Warehouse and for outbound shipments.
