

**Adventure Out! Explorify Sweepstakes (“Sweepstakes”)
OFFICIAL RULES**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES AND THE DISTRICT OF COLUMBIA, 18 YEARS OF AGE OR OLDER. VOID WHERE PROHIBITED. By entering, entrants are automatically signed up to receive marketing emails from Sponsor and/or Explorify, Rider Magazine in connection with their products.
